

## Terms and Conditions

- 1) All goods are transported for UK traffic under current RHA conditions of carriage and current CMR conditions of carriage for European traffic.
- 2) Goods are stored under standard UKWA conditions unless alternative agreement has been made.
- 3) Please note that for full loads we have allowed 1 hour for loading / offloading in the rates. Thereafter £50 per hour or part thereof will be charged in order to cover truck and driver waiting costs.
- 4) Please note that for full loads we have allowed 1 hour for loading / offloading in the rates. Thereafter £50 per hour or part thereof will be charged in order to cover truck and driver waiting costs.
- 5) Please note that for groupage (collections & deliveries) we have allowed 20 minutes for loading / offloading in the rates. Thereafter £15 per additional 20 minutes will be charged to cover truck and driver waiting costs. After 20 minutes on site we reserve the right to withdraw the vehicle and levy a wasted journey / cancellation charge.
- 6) All collections/deliveries are undertaken strictly on the basis that they are to/from commercial/business premises, and therefore does not include private or residential addresses.
- 7) Terms of payment 30 days from date of invoice.
- 8) Fuel is benchmarked at £0.95 per litre. The attached fuel mechanism will be applied as applicable.
- 9) In the event of any new legislative or enforced changes applying during the contract period we reserve the right to amend our pricing to recover any additional costs from the applicable date.
- 10) Annual tariff increases are likely to be applied by the Channel Tunnel & Ferry operators each year. In addition ferry operators will add marine surcharges to recover movements in the cost of fuel. These events are completely out with our control and should additional costs arise during the contract period we will amend our pricing from the applicable date of any price increases.
- 11) Additional Costs (all subject to availability and prior agreement);
  - FTL consignments:
    - Bank Holiday and weekend collections/deliveries will be subject to a minimum surcharge of £125.
  - Groupage Consignments
    - Bank Holiday and weekend collections/deliveries will be subject to a minimum surcharge of £50.
    - Tail Lift + £15, maximum weight is 1 ton / lift, subject to legislative changes.
    - Timed collections/deliveries + £15 (Mon - Fri 09:00 - 17:00).
    - Timed collections/deliveries outwith normal working hours will be charged at pricing agreed in advance.
    - Deliveries specified as AM/PM + £10.
- 12) ADR consignments will be subject to a standard £40 surcharge per consignment. In addition we reserve the right to pass on any applicable ADR surcharges incurred from third parties during the transportation of your consignment.  
This does not apply to limited quantity consignments.
- 13) CAF (Currency Adjustment Factor) – In the event there is a significant exchange rate movement we will contact you to discuss future pricing and / or the application of a CAF to future billing.
- 14) Where not already agreed within transport rates matrix we will apply extra collection and drop charges at £50 per extra collection / drop.
- 15) PODs and CMRs are available to you via our secure online portal which is accessed via our web site.
